- 1 (a) Max **two** marks per tool, one mark for identifying a tool, one mark for a description:
- **Tool** – Gantt Chart
 - **Description for Gantt** – e.g. show all stages/tasks to be done/show the critical path(s)/show key project milestones/progress of tasks as % completed/number of days to do a task

 - **Tool** – PERT Chart
 - **Description for PERT** – e.g. Program/Project Evaluation and Review Technique/used for critical path analysis/used for complex problems with multiple tasks

 - **Tool** – e.g. Project Management Software/Spreadsheet (allow 2 different types of software provided different valid reasons for use are given)
 - **Description** – e.g. allows progress to be tracked/allows easy production and updating of Gantt/PERT charts

- (b) Max **three** marks for each method that mentions case study, max two marks per method if there is no mention of the case study:

One mark per method, one mark for explaining why the method will be used for this case study, one mark for a further explanation.

Method: questionnaires/survey

- can ask standard questions
- ...so results can be analysed
- no need for analyst to be present
- respondents can remain anonymous, etc.

Method: interviewing

- allows questions to be tailored to those recording the race results
- allows follow up questions to be asked, etc.

Method: document search

- analyst sees exactly the format of the recorded results/certificates
- can be done at any time/place
- no need to disrupt sports events, etc.

Method: observation

- gives first-hand knowledge of how race results recording system works
- as analyst sees exactly how the results are recorded
- ...and so obtains reliable information
- little planning required, etc.

(c) (i) Content

- appropriate title, e.g. Sports Day Certificate
 - name
 - house name
 - date/year
 - number of points awarded
 - indication of being a winner
- One mark for any one of these to a maximum of **4** marks

Layout

- report looks like a certificate
 - report is well laid out
 - clearly a report, e.g. no drop down boxes, etc.
- One mark for any one of these to a maximum of **3** marks

Maximum total marks **6**

(ii) any two from, e.g.

- add name of race/event
- add race winner/First place
- remove number of points

(d) One mark for item, up to **two** marks for reasons for this case study. Reasons for choice must match item and be relevant for this case study.

- large screen
- to display results (outdoors)
- so everyone can see them

- printer
- print out lists of race entries/results
- print out winners' certificates

- bar code reader/scanner/RFID reader
- to identify runners
- log times

- WAP
- for remote
- connection of laptop/screen
- to school intranet

- adding student to race list
- recording race results
- updating house points totals
- updating individual student scores
- printing certificates
- checking/verification of results

One mark per data store, max 2










- race Entries/Results

(f) (i) One mark per point

- allocate a unique bar code for each student
- provide the students with their barcode (on shirt/wristband, etc.)/ use an existing school barcode
- provide/install barcode readers
- set up software to work with barcodes
- add barcodes to student records

(ii) One mark per point

- no need to ask for names/recognise students/no unauthorised entries
- saves time on data entry
- reduced data entry errors
- students can keep the same barcode for several years
- could be used for other systems/can make use of existing student barcodes

- (g) One mark per software package, one mark for explaining why the package will be used for this case study, allow specific examples.

Package: spreadsheet

- can automate calculations for updating point totals
- house results can be displayed graphically
- validation rules can easily be set up
- can integrate with word processor/OLE, etc.

Package: word processor

- mail merge can be used to print certificates
- can integrate with spreadsheet/database/OLE
- can set up templates for certificates, etc.

Package: database (management system)

- good management of data for students and houses
- can automate calculations for updating point totals
- can link to other data sources, e.g. school records
- easy to design input/output, etc.
- can integrate with word processor/OLE, etc.

Package: presentation/DTP

- design certificates
- can mail merge with other data sources, e.g. school records

- (h) Marking points max 6

- loop through all races
- identify/input race
- input first placed student
- input second placed student
- input third placed student
- look up/input each student's house
- check house for each place
 - add 10 to correct house total for first
 - add 5 to correct house total for second
 - add 2 to correct house total for third
- display house names and updated totals

Or

- loop through all races
- identify/input race
- loop
 - ...for number of students in race
 - input student
 - input place/points
 - look up/input each student's house
 - add student points to correct house total
- display house names and updated totals

(i) One mark per point

Test data max 2

- use of test data sets
 - normal test data has known outcomes
 - extreme test data checks validation rules
 - abnormal test data should produce error messages
 - mention of normal, abnormal, and extreme data
- (all 3 with no valid expansions, one mark if above not given)

Types of testing max 2

- black box
- white box
- system
- alpha
- beta
- user, etc.

Other

- testing that the race recording system meets the requirements for the school [4]

- (j) **two** marks for description of parallel running
up to **two** marks for reasons chosen, for **two** marks at least one reason must apply to school sports day recording system.

Description – operate both systems together side by side
– for one sports day

Reason – good for training/familiarisation results recorders
– results from both systems can be compared
– less risk of failure
– if new system fails results recorders can use old manual system as a backup [4]

- (k) up to **four** points from
- consider if objectives/requirements of new system have been met
 - compare results with old and new systems
 - ...obtained during parallel running
 - discuss with results recorders whether or not new system easy to use
 - ask the students whether or not the new system worked well
 - ask spectators if new system worked well [4]
